#### Using Contract Intelligence to support the repapering process

**Collect documents** – Quickly collect documents from a variety of sources, including iManage Work, or simply upload with drag and drop.

Assess and refine repapering scope – As documents are reviewed, assess repapering impact to the portfolio and refine the scope of repapering efforts to create an informed strategy that's resourced accurately and efficiently.

**Identify and organize documents** – Interpret similarities in agreements to cluster documents by type and identify duplicate documents allowing review prioritization and scope confirmation.

**Focus on critical provisions and extract information –** Capture key language in agreements using a toolbox of extractors that allow for efficient and flexible information gathering to identify agreements requiring further action.

**Cluster & Classify –** Use machine learning to cluster and classify documents based on content.




**Extract** – Use extractors from the Extractor Library or easily train new extractors using the Extractor Toolbox to identify key information from documents.
